

TAX CREDIT PROGRAM INFORMATION SHEET

CITY OF CLAREMONT, NC (CATAWBA COUNTY)

Welcome to **Oxford Crossing**. Our community is operated under Section 42 of the LIHTC Program of the Internal Revenue Code. This program is designed to facilitate the housing needs of moderate and middle-income households. Residence at **Oxford Crossing** requires that applicants meet certain qualifying standards established by the government. This program qualification is not connected with Section 8, however, housing choice voucher holders are encouraged to apply. Residency at **Oxford Crossing** is limited to those households having moderate incomes.
