## TAX CREDIT PROGRAM INFORMATION SHEET

### CITY OF SUNNYVALE, TX (DALLAS COUNTY)

Welcome to **Riverstone Trails**. Our community is operated under Section 42 of the LIHTC Program of the Internal Revenue Code. This program is designed to facilitate the housing needs of moderate and middle-income households. Residence at **Riverstone Trails** requires that applicants meet certain qualifying standards established by the government. This program qualification is not connected with Section 8, however, housing choice voucher holders are encouraged to apply. Residency at **Riverstone Trails** is limited to those households having moderate incomes.

In **Sunnyvale, TX** (Dallas County), the maximum allowable income (by household size) are as follows:

In addition to standard wages, income includes gross monies received from many sources such as alimony, child support, pensions, and social security. A complete definition of income is detailed in the application. All information on income provided by applicants must be verified before occupancy. ***This qualification and certification process must also be completed annually.*** Failure to comply with recertification could result in ineligibility for this program.

The rents at **Riverstone Trails** are limited by statute. Currently, the rents charged by bedroom are:
